- Plant tour Attendees toured the location of the boiler facilities and where the new BFB boiler will be placed (bay 1). Shown the three steam turbines and location of the new Siemens 7.62 MW BPSTG, which will replace the existing 8.9 MW GE BPSTG.

Action Items

- 1. Hiawatha First Nation asked to receive a CIM and Equity Package to review
- 2. The Town of Ajax and Index Energy Ajax Corporation will meet to review the status of the 6.2 km underground steam distribution facilities, which are owned and maintained by the Company in the Town of Ajax streets.
- 3. The Town of Ajax and Index Energy Ajax Corporation will meet to review the potential expansion of the district heating and cooling facilities to benefit economic growth at the Facility and within the Town of Ajax.
